Associate Member Benefits:

Associate members receive a placement in RMA's membership directory and other recognition, a subscription to the Rice Executive, and discounted member registration rates for the annual RMA Convention. Associate members are eligible for committee service. Industry Associates have access to RMA Online, an Internet information service maintained by RMA for its membership (the service is available to Allied Server members for a subscription fee). Through RMA, associate members are also affiliated with the USA Rice Federation, which represents all segments of the U.S. rice industry.

Associate Member Categories and Annual Dues (Effective December 8, 2010):

Industry Associate

- \$5,000** **act as agent for contracts/sales of rice;**
- \$5,000** **buy, use and/or market rice and/or rice products.**

Allied Server Associate

- \$1,500** **Entities not included in the classifications above.**
- \$250** **RMA Online available to this member category.**

Honorary Membership:

- \$2,500** **LIFETIME EMERITUS, Any retired professional in the rice milling industry**
- \$250** **ANNUAL EMERITUS, Any retired professional in the rice milling industry**

Dues are for the association's fiscal year beginning August 1 and will be prorated accordingly. RMA's Board of Directors will review the application. Contributions to RMA are not deductible as a charitable contribution for federal tax purposes. In compliance with the Omnibus Budget Reconciliation Act of 1993, a portion of membership dues is not deductible as a business expense due to lobbying activities. Notice of the non-deductible portion will be provided annually and with dues notices. Companies eligible for RMA mill membership are not eligible for associate membership.
